### **Unwinding the Attachment Dilemma**

How many times have you scratched your head wondering what on earth an insurance company might request in support of your claims? Over the years, many offices just resort to the old "when in doubt, print it out" methodology of sending every X-ray, perio chart, narrative, etc. that a payer might request to make sure there are no delays in getting a claim processed.

DentalXChange has partnered with National Electronic Attachment (NEA) to finally take the guesswork out of this process. Each insurance company provides their own personal "rules" as to exactly what supporting documentation they would like to see for a given procedure.

We load these rules into ClaimConnect so that you no longer have to guess what attachments might be needed. Simply upload your claims electronically and the system does the rest. If a claim has a

procedure that requires an x-ray for instance, the claim will be suspended alerting you that the attachment is needed. Simply open your NEA FastAttach software and you will see the same claim listed there. Once you upload the attachment to NEA, sit back and relax because NEA will transfer the unique image ID to DentalXChange which will be inserted into your claim and automatically released to the insurance company where they are able to view your claim and the attachment on their screen side by side.

Best of all, it's extremely easy and cost effective to get started. The system is compatible with any digital imaging system, or you can buy a very affordable scanner that is able to scan not only paper documents, but x-rays as well. If you are not quite ready to add



#### Section 179 Expense ends after 2010

The American Recovery and Reinvestment Act contains a limited provision where businesses can elect to expense, rather than depreciate, the cost of machinery, equipment and other tangible property placed in service. In 2010, the maximum deduction is \$133,000. After 2010, the cap returns to the prior limit of \$25,000.

### Mac or PC Server? It's TCO.

The (cyber) age-old question rears its head...again. Mac or PC? Or more specifically: a Mac or Windows server? It's been argued about for years.

Surprisingly it's not just small businesses that are making the big switch to Macs. Among the business elite that have switched at least some of their departments from PCs to Apple computers are Home Depot, Google, Oracle, and the U.S. White House.

He continues: Macs have a lower TCO (total cost of ownership). Most experts will tell you that the difference between TCO for an equally outfitted PC and Mac are not much different. But when you take into consideration the soft cost of being down and dealing with tech support that's so widely associated with PC use, the Mac blows PCs away. Not that I would recommend that anyone do this, but I have not run virus software on my Macs...ever. Consider this: If you own a small business with 10 employees on PCs what does it cost if you get a virus and half of your employees are down?
